**Summary:** Correspondence, synopses of stories and movie scripts, publicity material, notes, and clippings relating chiefly to William Surrey Hart's career as a star of silent western films, Hart's lawsuit against United Artists, and the efforts of Hart's son to contest his father's will.

## Biographical Note

### William Surrey Hart

<i>Date</i>	<i>Event</i>
circa 1874	Born, Newburgh, N.Y.
1890-1914	As an actor, barnstormed the country playing opposite leading stars such as Julia Arthur and Modjeska, later finding success in western plays
1914	Made first screen appearance in <i>Jim Cameron's Wife</i> , a California production by his friend, Thomas H. Ince
1917-1926	Became a world-famous film star and director of many movies in which he played the leading roles
1921	Married Winifred Westover, actress and his leading lady in several films
1926-1940	Claimed that he was kept out of movies by Joseph Schenck, head of United Artists Corp., and other businessmen in the movies
1929	Published <i>My Life East and West</i> . Boston: Houghton Mifflin
1940	Was awarded \$375,000 by the New York Supreme Court in suit against United Artists for selling <i>Tumbleweeds</i> in violation of contract
1946, June 23	Died, Hollywood, Calif.

## Scope and Content Note

The Gatewood W. Dunston Collection Relating to William Surrey Hart material was collected by Gatewood W. Dunston, of Norfolk, Virginia, over a period of nearly twenty years. It includes correspondence, 1929-1955, synopses of Hart's stories and movie scripts, 1914-1918, publicity material, notes on films, and clippings. The material relates chiefly to Hart's career as a pioneer star in silent western films.

The correspondence includes letters from Hart to Dunston discussing Hart's films and movie career and letters about Hart written by others. There are also clippings regarding the law suit which Hart won against United Artists in the New York Supreme Court in 1940, and material concerning the efforts of Hart's son to contest his father's will, 1946-1950.
