Scope and Content Note

The papers of Cadmus Marcellus Wilcox (1824-1890) span the years 1846-1887 and consist of correspondence, maps, an autobiography, drafts, notes, and copies of reports relating to the Army of Northern Virginia and to various Civil War campaigns. Also in the collection is material on the Mexican War. Correspondents include Edward P. Alexander and Robert E. Lee.
