## **Biographical Note**

Labor leader Joseph A. Yablonski was born in Pittsburgh, Pennsylvania, March 3, 1910. He followed his father into the coal mines at age fifteen and joined the United Mine Workers of America. The death of his father in a mining accident in 1933 inspired Yablonski to become active in union politics and in 1934 he was elected president of a UMWA local. He married Margaret Rita Wasicek. He served on the executive board of District 5, with oversite of UMWA locals in the greater Pittsburgh area from 1934-1942, and in 1958 was elected president of the district, serving until he was forced out by union president William Anthony Boyle in 1966. Through the 1960s Yablonski worked through union and state political venues to raise miners' pay and to add pneumoconiosis (black lung) to the list of compensated diseases in Pennsylvania. In 1969 Yablonski challenged Boyle for the presidency of the UMWA and lost in a disputed election.

On December 31, 1969, Joseph A. Yablonski was murdered with his wife and twenty-five year old daughter, Charlotte, at the family home in Clarksville, Pennsylvania, by killers hired by Boyle. Investigations of these murders by Pennsylvania and federal authorities and the federal and state prosecution of Boyle, the killers, and other co-conspirators proceeded throughout the decade of the 1970s.

## **Scope and Content Note**

The material in the Joseph A. Yablonski Legal Case Collection was assembled by an unknown person close to the Yablonski family. The collection relates entirely to the investigation by Pennsylvania and federal authorities of the murders in 1969 of labor leader Joseph A. Yablonski with his wife Margaret and daughter Charlotte, and to the subsequent state and federal trials of United Mine Workers of America President William Anthony Boyle, who ordered the murders, and his coconspirators. The collection spans 1923-1978, with the bulk of the material concentrated in the period 1970-1977. The records are organized into three series: Pennsylvania Trials and Investigations, Federal Trials and Investigations, and Restricted.

The bulk of the <u>Pennsylvania Trials and Investigations</u> series documents the state criminal trials of Boyle and seven hitmen and co-conspirators. Material includes trial and hearing transcripts, pre-trial and post-trial motions, confessions and other statements, opinions, records of appellant proceedings and other legal documents. The series also includes crime scene photographs taken by Pennsylvania authorities and clippings from western Pennsylvania newspapers.

Most of the <u>Federal Trials and Investigation</u> series consists of the Federal Bureau of Investigation file relating to the bureau's investigation of the Yablonski murders and other files relating to a witness and to crime scene photographs taken by Federal Bureau of Investigation agents.
